COURSE DESCRIPTION

This course will examine the history, practices, theories, and impact of Canadian foreign and defence policy. It will approach the topic from both a "Canada in the World" perspective rooted in conflicting variants of international relations theory as well as from a policy-making perspective which focuses on the influence of domestic political leadership, institutions, societal actors, and identity questions. The course will prompt students to think critically about a wide range of questions that motivate the study of Canadian foreign policy and its implementation.

COURSE OBJECTIVES To introduce students to the historical, theoretical, and institutional

foundations of Canadian foreign policy.

To develop analytical skills that improve understanding, explanations, and critical assessments of Canadian foreign policy and Canada's

global influence.

# Class Participation (10%)

Class participation does not equal attendance. The class participation grade will be based on (1) the quality (not quantity) of engagement in class discussions (5%), and (2) a short (6 minute) multi-media presentation on your research topic outlining your research question, key argument(s), theoretical perspective(s), and sources used (5%). **Presentations will be scheduled from November 7**<sup>th</sup>.

# Memo to the Minister Assignment (15%)

Each student will prepare a policy brief of no more than 700 words (single spaced; a template, detailed instructions, and scenarios will be provided) that simplifies and assesses a contemporary Canadian foreign or defence policy challenge and presents policy recommendations or positions for consideration by a senior policymaker. Students will receive the assignment on Friday, October 10<sup>th</sup>, and it is due in class on Friday, October 24<sup>th</sup>. Late penalty is 5 percentage points per day.

# Analytical Research Essay (30%)

- (1) Select an historical or contemporary Canadian foreign policy theme or challenge, develop a research question and preliminary bibliography that includes both primary and secondary sources, and **get it approved by the instructor by Friday, Oct. 10**<sup>th</sup> (late penalties will apply after Oct. 10<sup>th</sup>, deducted from your overall essay grade);
- (2) Undertake primary and secondary research on your topic, develop a working thesis statement, and prepare a short six minute multi-media presentation outlining your research question, thesis, key argument(s), and theoretical perspective(s) you use or challenge in your explanation (Your presentation will be scheduled to coordinate with a class that covers related issue themes or issues, beginning November 7th);
- (3) Prepare and submit a formal 10-12 page essay. Detailed instructions and marking rubric will be provided in class. Final paper is due via d2l dropbox on Monday, November 24<sup>th</sup> (4:00pm). Late penalty is 5 percentage points per day.

#### Midterm Exam (25%)

The closed-book midterm examination will be multiple-choice format, held on **Friday, October 31**<sup>st</sup>. It will consist of 60 questions and cover (1) all required readings through Parts I, II, & III (inclusive of

September 10<sup>th</sup> thru October 29<sup>th</sup>) and (2) all lectures and class discussions for the same period. (*Closed book: no textbooks, notes, laptops, mobile phones, etc., permitted.*)

Take-Home Final Exam (20%)

The take-home final will take the form of one formal essay (6-8 double spaced pages), properly cited and formatted, and two or three short answer questions. The take-home final exam will be distributed in class on Friday, November 28<sup>th</sup> and will be **due at 4:00pm on**Wednesday, December 10<sup>th</sup>, via d2l dropbox. Late penalty is 10 percentage points per every 12 hours.

**GRADE SCALE**

#### **University Regulations**

## Plagiarism and Other Forms of Academic Misconduct

Academic misconduct in any form (e.g. cheating, plagiarism) is a serious academic offence that can lead to disciplinary probation, suspension or expulsion from the University. **Plagiarism**, which involves the failure to properly acknowledge the contribution of others, can take several forms, including the failure to properly cite sources, the extensive use of paraphrasing, the buying of papers, and the submission of a single piece of work in two separate courses. **Cheating** also takes many forms including communicating with others during tests and exams, the use of material not authorized by the instructor during exams, and allowing others to view your examination paper or attempting to read the examination papers of others. Students are also cautioned that lectures and materials produced by an instructor in a course are the intellectual property of the instructor. Any distribution of these materials – including hard copy and online – without the instructor's written approval, constitutes a breach of copyright law and an act of academic misconduct. All such offences will be taken seriously and Faculty of Arts policy requires that all offences be reported.

#### Freedom of Information and Protection of Privacy (FOIP)

FOIP legislation requires that instructors maintain the confidentiality of student information. In practice, this means that student assignment and tests cannot be left for collection in any public place without the consent of the student. As such, assignments and tests will normally be returned directly to students, either during class or office hours, or electronically through Desire2Learn (D2L). Final exams are not returned to students but can be viewed by making arrangements with the instructor. Any uncollected assignments and tests will be destroyed after three months; final examinations are destroyed after one year.

#### **Absence from a Test**

Students who are absent from a scheduled term test for legitimate reasons (e.g. illness with the appropriate confirming documentation or religious conviction) are responsible for contacting the instructor via email within 48 hours of the missed test to discuss alternative arrangements. A copy of this email may be requested as proof of the attempt to contact the instructor. Any student who fails to do so forfeits the right to a makeup test.

#### **Deferral of a Final Examination**

Deferral of a final examination can be granted for reasons of illness, domestic affliction, religious conviction, to those with three (3) scheduled final exams within a 24-hour period, and for unforeseen circumstances. Deferred final exams will not be granted to those who sit the exam, who have made travel arrangements that conflict with their exam, or who have misread the examination timetable. The decision to allow a deferred final exam in the Faculty of Arts rests not with the instructor but with Enrolment Services. Instructors should, however, be notified of any absences due to unforeseen circumstances.
